Stream B

If you are an assessor who has not submitted a Tenancy Lighting Assessmentⁱ in the last 3 years, you will need to fulfil all requirements under 'Stream A' and also complete the CBD Online Learning Module and pass the CBD TLA Training Examⁱⁱ within 3 months of accreditation.
